President's Letter - Rob and Terri Sherwood

The CRDA board was pleased to see such good attendance of members and visitors at the Harvest Moon dance on September 17th. Many of our CRDA cuers took turns at the mic, with special thanks to Patrick and Eileen, Ed and Elvira and John and Karen for their teaches at the early session. Hopefully, all those in attendance consider this a warm-up for the Gala at Greeley in the wonderful UNC ballrooms on November 3rd and 4th.

I would like to ask all those who listen to Colorado radio stations to keep their ears open for the PSA (public service announcement) that is now being distributed throughout the state. We had a potential dance couple visit Harvest Moon after hearing the PSA on Smooth Jazz 104.3 and visiting CRDA.net. If you have not yet heard the PSA, please visit our web site home page and listen! If you hear it on the air, please let a board member know where and when it was aired, so we can try to get a feel for the amount of air time we are getting.

The second project to promote our wonderful hobby is to expand the beginner class season into the spring, and, in addition, start to bring in new people from a larger target audience than just existing square dancers. The Round of the Month meeting on October 7th will be expanded with some extra time for cuers to "kick around ideas" on how to funnel new dancers attracted by Dancing with the Stars into our hobby. While a basic concept has been discussed by the dance-promotion committee, and the full board, we need not only cuer input, but for our teachers to help us expand our current beginner programs.

We used the Harvest Moon dance to test out our newly acquired hearing-enhancement equipment. While there were no problems with the equipment itself, we found lots of glitches in how it needs to be connected to the sound equipment in each room for the Gala. It may turn out that the only way to guarantee a consistent feed to the transmitters in each room is to use a "recorder-box" connection that will not change regardless of who plugs what into a mixer jack. If that is the case, then unlike at Harvest Moon, the sound enhancement feed would include both music and the voice cues. (Continued on Page 3)



CRDA BOARD OF DIRECTORS MEETING

August 19, 2006

The meeting was called to order by Rob Sherwood at 9:58 a.m. at the Rose Hill Grange. The minutes were corrected that the cuer's name is Blackford, not Blackbird, and that there is not a new committee looking for a hall, but a submittal of previous information. The minutes were approved as corrected. There was no correspondence.

<u>Treasurer's Report</u> – Ben Moore submitted a written report, noting that the miscellaneous income of \$.16 income was from Pay Pal verifying the account. The report was accepted as presented.

<u>President's report</u> – The 53rd National committee did approve the funding of our two projects. Rob Sherwood will make individual phone calls to get feedback from the cuers regarding spring beginner classes.

<u>Vice President's report</u> – The nominating committee has asked people and been turned down. They have also emailed out of Denver cuers looking for their suggestions for new people for the board..

<u>Round Notes</u> – Nancy and Bill Piechota are resigning and we are looking for a replacement. Ben Moore suggested contacting Rose del Sol.

<u>Cuer Selection Committee</u> – Paul and Linda Robinson will be the second couple for 2009. The other couple for 2009 is the Warlocks.

<u>Gala</u> – 54 couples have registered so far. Cindy Van Hooser, in charge of the after party, has suggested having hot dogs and buns and that the board donate the money for them instead of bringing food. A motion was passed that CRDA pay up to \$100 for the after party and that we will have a donation jar to help recoup the cost. A host couple for the Nelsons is still needed. It is better if the hosts are not board members.

<u>Hall of Fame -</u> The new point system has worked very well. Three couples have been approved: Don and Peggy Hutchinson, Chris and Terri Cantrell, and Harold and Cindy VanHooser. The selected couples get free registration at the Gala, a gift, and their name on a plaque. A motion was passed that every year up to \$100 per inductee couple can be spent on these expenses.

<u>Membership</u> – Jean Montgomery passed out a new roster. We now have 128 members . Seven or eight couples who got a free membership last year did renew.

CO State Square Dance Assoc. Representative – No report.

<u>Denver Area Square & Round Dance Council Representative</u> - No report.

<u>Promotion and publicity</u> - No report.

Round of the Month – Jack Baker stated that they are not co-chairman, but only substituting for Ty and Ann Rotruck duringthe summer. 3 ½ couples attended this month and Rumba Erotica 3 was chosen. for the Round of the Month. The next meeting will be Sept. 9, the second Saturday instead of the first Saturday because of Labor Day. In September the Harvest Moon Dance teaches are usually selected to be the Round of the Month. Jack Baker will check if certificates are being sent to the choreographers of the round of the month selection.

Strolling Rounders – Bakers and Hutchinsons are working on visitations before the Harvest Moon dance and the Gala.

<u>Web Page</u> - The web page is averaging 49 hits a day. Hotel information for the Harvest Moon dance has been added; Pay Pal will be up soon. The vote list for the Gala will be on it soon, as will an electronic version of the membership form.

Historian - Eileen Krause got additional information from old syllabuses which she will give to Ty Rotruck.

Revision of Constitution – Adjustments have been made to responses we have received. The President's letter in the Round Notes will remind people that they have all had a chance to read the changes and to bring their copy to the Gala. A copy will be provided at each table at the meeting and some at the registration table. Chris Cantrell will summarize the changes for Rob Sherwood to read at the Gala meeting. Most changes correct the by-laws to reflect what we actually do now. Changes include that the president is a non-voting member of every committee, the change in requirements for publishing the by-law changes, and that the ROM now allows teacher couples to moderate and non-teacher couples to vote.

<u>Unfinished Business</u> - High Definition Music made four 30-second versions of the PSA which we listened to. The cost is \$500 with the 53rd paying half. Rob Sherwood will burn CD's and Ben Moore will get them to all the radio stations before the September classes start. Including a phone number on the PSA for people to call for more information was more expensive than expected. Instead listeners will be directed to the web page. It was suggested that we have a form at beginner classes asking "where did you hear about us?" to see if we are getting any results from the PSA. Also a counter on the web-site would be helpful to see if hits are coming as a result of the PSA.

The Fishers have agreed to do a Sunday afternoon clinic at Rose Hill. This would be an education clinic aimed at cuers. The cost to CRDA would be \$200 for 2 ½ -3 hours, probably from 2 to 5. It would be free for cuers and instructors. We do not yet know if the Blackfords will do a teach next year. Refreshments?

Bob Kurczeski lent us samples of the sound enhancement equipment. Rob Sherwood presented price quotes from him and from Ceavco AV. We agreed to buy from Kurcezeski 3 Williams transmitters, and 12 receivers. Dancers can buy an earpiece for \$15 or bring their own. Also Chris Cantrell will purchase some inexpensive ear buds which will be available for people to try the equipment. They can also bring their own receiver. The equipment will be signed out for every dance session at the Gala with a driver's license or something similar to be used as a deposit. Ben Moore expressed the opinion that the cost is not worth the use we will get from the equipment.

Dennis Pluim announced that there will be a drawing at the Gala for a wood design made by Marcia Knight. Herman Allmaras announced the Peach Promenade will be August 25 and 26, and thanked Chris Cantrell for all his work at URDC.

The next meeting will be October 14, 2006. The meeting was adjourned at 12:00 p.m.
